



Parent or Guardian Consent Form

The Sodbury Sportive is a challenging event that is held on open public highways. It is the personal responsibility of each participant to ensure that they ride safely, with due respect for other road users, and in accordance with the Law and the Highway Code.

All participants under the age of 18 must have had this consent form completed and signed by their parent or guardian.

A parent or guardian or other nominated responsible rider over 18 must accompany all participants under the age of 16, throughout the event.

Entry Conditions

- 1. Cyclists in the Sportive must use a mechanically sound bicycle adjusted to suit the rider. The organisers will not check the state or suitability of the bike at any time and responsibility for ensuring the bike is roadworthy remains with the parent or guardian.
- 2. Whilst cycle helmets do not prevent accidents, they drastically reduce the risk of serious head injury if an accident occurs. Parents or quardians therefore must supply a properly fitted and adjusted helmet to a recognised safety test standard, (e.g. BS EN 1078,).
- 3. Your son or daughter or ward will be expected to behave in a safe and orderly manner and failure to comply with this may mean he or she will be excluded from the event.
- 4. Please return the completed consent form to the Organisers before the event. Failure to do so could result in the Young Person not being allowed to ride.
